Dear Madam/Sir,

You receive this letter to inform you that with effect from July 1st, 2023 Hamilton Bonaduz AG (Process Analytics Business) has decided to start selling directly in Denmark.

The reason for this change is the strategic decision of Hamilton to continue to expand its direct sales presence in additional countries in the European Union and Globally. Therefore, Hamilton has terminated the distribution contract with Insatech A/S. Both parties will secure a smooth transition, where you as customer will be secured on-time deliveries as usual.

How will the transition period be handled?

Between today and June 30th, 2023 all orders shall be placed still at Insatech A/S as usual, even if their delivery takes place after June 30th. Also any product related claim or complaint shall be routed thru Insatech A/S until this date.

Open frame orders will be executed by Insatech A/S beyond June 30th, 2023 until their individual fulfillment date. Afterwards they shall be renegotiated with Hamilton directly.
